IMPORT ENTRY (Unaccompanied Personal Baggage)

CAUTION: Breaches of the Customs and Excise Act 1996

The declaration set out below is a declaration under the Customs and Excise Act 1996. You should be sure that it is true and correct before you sign it. Heavy penalties are provided for breaches of this Act as, for example, erroneous or false declarations or entries, production of false information or documents. These penalties can involve:

- Forfeiture of the goods concerned to the Crown, in addition to a monetary fine.
- Imprisonment for a term not exceeding 6 months or a fine not exceeding \$10,000 in the case of a wilfully false declaration.

NOTES

1. This form should be used to enter for home consumption, unaccompanied personal baggage (other than motor vehicles, ships, or aircraft), that belongs to a passenger arriving in New Zealand.
2. If the baggage contains goods for business and /or commercial purposes, use form C4.
3. You should lodge with this form a separate and comprehensive inventory of all goods in the baggage.
4. In all cases a properly completed "Customs Delivery Order" form should accompany the entry at the time of lodgement.
5. If you have answered yes in Paragraph 1 overleaf, indicate the category relating to the goods e.g., (v) = For goods used in your business.
